Certificate of Compliance

We herewith confirm that all ArmaFlex, ArmaComfort and ArmaSound products with the exception of ArmaFlex Protect, manufactured and/or distributed in the European Union does not contain any substance listed in REACH SVHC list (candidate list – in the version of January 21st 2025), REACH restriction list (Annex XVII – in the version of 12th december 2023) and REACH annex XIV (in the version of April 08th 2024) under due consideration of the relevant limits of 0,1 %.

Further we confirm that the product does not contain any substances listed in directive 2011/65/EU (RoHS) in its latest version (including its amendment (EU)2015/863 and latest update from July 22nd 2019).

All products produced by Armacell in Europe does not contain PFAS (Perfluoroalkyl and Polyfluoroalkyl Substances). Armacell does not use any PFAS in production and in manufacturing processes.

We also confirm that products, manufactured and supplied by the Armacell-group complies with European regulation 2019/1021 and does not contain prohibited materials in due consideration of relevant limits.

All products manufactured and placed on the market by Armacell do comply with EU regulation EU 2017/821 and Dodd-Frank Act (DFA) section 1502 and does not contain conflict minerals.

Further we confirm that ArmaFlex products are compliant with TSCA Part 751 – Regulation of certain chemical substances and mixtures under section 6 of the toxic substance control act, and does not contain following prohibited substances:
